Method and Amount of Initial Payment Preferred Billing Cycle (monthly, semi-annually, school year)

This certifies that I have rented from Violins & More of Lynchburg, Inc., the above described outfit for which I agree to pay a **monthly rental fee of \$_____ plus tax, for a total of \$_____**. If I choose to add insurance, the **total monthly fee comes to \$_____**. The first payment shall be paid upon the signing of this agreement, and subsequent payments shall be charged to the credit card on file on the day of month the rental began. Invoices which are 30 days past due because of a declined or expired credit card number will be subject to a late fee of \$5 per month. If the lessee fails to respond for more than 60 days to Violins & More inquiries as to new card numbers or expiration dates, then Violins & More reserves the right to reclaim the instrument and the lessee will be responsible to pay collection costs.

The lessee can cancel this agreement at any time by returning the instrument outfit to Violins & More of Lynchburg, Inc. This agreement can also be canceled by Violins & More of Lynchburg, Inc., if rental payments are more than 60 days past due.

The lessee will be responsible for any damage to the instrument outfit while in their possession and will be required to make payment for damages, devaluation, or replacement. Compensation must be made prior to the repair or exchange of damaged instrument. The lessee will not be held responsible for defects in workmanship.

Optional Insurance: With Violins & More rental insurance, the lessee reduces the standard repair or replacement cost by 70% (i.e., the lessee is responsible for 30%). Rental insurance does not cover loss, theft, or shipping. Violins/Violas: \$3/month, Cellos: \$5/month, Basses: \$7/month.

Violins & More of Lynchburg, Inc., will credit 40% of paid rental fees (not including insurance and tax) toward the purchase price of your Violins & More rental instrument outfit or an upper level retail instrument.
